A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN ENTITY/STATE AGREEMENT BETWEEN THE CITY OF SHREVEPORT AND THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT FOR THE CITY OF SHREVEPORT TRAFFIC SIGNAL BACKUP PROJECT AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

WHEREAS, the Shreveport Traffic Signal Emergency Power Backup project is included in Project G00001 – Traffic Signal System Improvements;

WHEREAS, appropriations for City Project G00001 were authorized in the 2021 Capital Projects Fund Budget, Ordinance 136 of 2020, and the Mayor was authorized to execute all contracts to expend and receive the fund;

WHEREAS, Louisiana Department of Transportation and Development (DOTD) needs a resolution specifically giving the Mayor authority to sign on behalf of City of Shreveport for

contracts with DOTD for this specific project, G00001-Shreveport Traffic Signal Emergency Power Backup.

WHEREAS, two old Entity/State Agreements, 737-09-0104 H.006472 and 737-09-0108 H.006475, were combined and superseded with a new Entity/State Agreement - State Project No, H.006472, Federal Aid Project No. H006472, City of Shreveport Traffic Sig Bkup, Local Routes, Caddo Parish.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport in due, legal and regular session convened, that Adrian Perkins, Mayor, be and is hereby authorized to execute on behalf of the City of Shreveport an Entity/State Agreement with the Louisiana Department of Transportation and Development for the City of Shreveport Traffic Signal Backup Project.

RESOLUTION NO. 95 OF 2021

A RESOLUTION EMPLOYING PROFESSIONALS WITH RESPECT TO THE ISSUANCE BY THE CITY OF SHREVEPORT, STATE OF LOUISIANA OF NOT EXCEEDING TWO HUNDRED FORTY-TWO MILLION SIX HUNDRED THOUSAND DOLLARS (\$242,600,000) OF GENERAL OBLIGATION BONDS, IN ONE OR MORE SERIES, ON A TAXABLE OR TAX-EXEMPT BASIS; AND OTHERWISE PROVIDING WITH RESPECT THERETO

WHEREAS, this City Council, acting as the governing authority (the "Governing Authority") of the City of Shreveport, State of Louisiana (the "City" or "Issuer") is considering the issuance by the City of not exceeding Two Hundred Forty-Two Million Six Hundred Thousand Dollars (\$242,600,000) of its Taxable or Tax-Exempt General Obligation Bonds, in one or more series (the "Bonds"), to be issued under and pursuant to the provisions of Article VI, Section 33 of the Constitution of the State of Louisiana of 1974, Sub-Part A, Part III, Chapter 4 of Title 39 of the Louisiana Revised Statutes of 1950, as amended (collectively, the "Act") and other constitutional and statutory authority;

WHEREAS, the Bonds shall be issued upon approval by the qualified voters of the City of: (i) Proposition Number 1: Seventy Million Six Hundred Fifty Thousand Dollars (\$70,650,000) for

the purposes of constructing, acquiring, and improving public facilities and equipment for the police department, the fire department, along with acquiring the necessary buildings, land and/or rights therein, equipment and furnishings therefore, and paying the costs of issuance thereof; (ii) Twenty-Two Million Seven Hundred Forty Thousand Dollars (\$22,740,000) for the purposes of technological upgrades and improvements, and economic development, including but not limited to industrial park and workforce development facilities, along with appurtenances and infrastructure related thereto and acquiring necessary buildings, land and/or rights therein, equipment and furnishings therefore, and paying the costs of issuance of the Bonds; (iii) Proposition Number 3 Sixty-Four Million Seven Hundred Thousand Dollars (\$64,700,000) for the purposes of constructing, acquiring, and/or improving water and sewer systems, along with appurtenances thereto and acquiring necessary buildings, land and/or rights therein, equipment and furnishings therefore, and paying the costs of issuance thereof; (iv) Proposition Number 4: SixtyThree Million Three Hundred Seventy-Five Thousand Dollars (\$63,375,000) for the purposes of for the purposes of constructing, acquiring, and/or improving streets, highways, bridges, and drainage systems, along with appurtenances thereto and acquiring necessary buildings, land and/or rights therein, equipment and furnishings therefore, and paying the costs of issuance thereof; and/or (v) Proposition Number 5: Twenty-One Million One Hundred Thirty-Five Thousand Dollars (\$21,135,000) for the purposes of constructing, acquiring, and/or improving public facilities for parks and recreation, along with acquiring the necessary buildings, land and/or rights therein, equipment and furnishings therefore, and paying the costs of issuance thereof;

WHEREAS, the Bonds shall bear interest at a rate or rates not exceeding seven per centum (7.00%) per annum, if taxable and not exceeding five per centum (5.00%) per annum, if tax-exempt and shall be for a term not exceeding twenty (20) years from the date of issuance; and WHEREAS, this Governing Authority desires to hire professionals in connection with the issuance of the Bonds.

NOW, THEREFORE, BE IT RESOLVED by the Governing Authority of the Issuer, that: SECTION 1. Employment of Bond Counsel. This Governing Authority finds and determines that a real necessity exists for the employment of bond counsel in connection with the issuance of the Bonds, and accordingly Washington & Wells, LLC, Shreveport, Louisiana, and Boles Shafto, LLC, Monroe, Louisiana are hereby employed as bond counsel (together, "Bond Counsel") to the Issuer to do and perform comprehensive legal and co-ordinate professional work of a traditional legal nature with respect to the issuance and sale of the Bonds.

Bond Counsel shall prepare and submit to this Governing Authority for adoption all of the proceeding's incidental to the authorization, issuance, sale and delivery of the Bonds and the election associated therewith and shall advise this Governing Authority as to the issuance and sale thereof and shall furnish their opinion covering the legality of the issuance thereof. The legal fees of Bond Counsel in connection with the issuance of the Bonds shall not exceed the amount provided by the Attorney General's Guidelines for Fees and Services of Bond Attorneys for comprehensive legal and coordinate professional work in the issuance of general obligation bonds, said fees to be payable solely out of funds derived from the sale of the Bonds and the election associated therewith.

SECTION 2. Counsel to the City. Ronald Lattier, City Attorney for the City shall serve as counsel to the City in connection and delivery of the Bonds.

SECTION 3. Employment of Municipal Advisor. This Governing Authority finds and determines that a real necessity exists for the employment of a municipal advisor, and

accordingly, Government Consultants, Inc., Baton Rouge, Louisiana, is hereby appointed and employed as municipal advisor (the "Municipal Advisor") to the Issuer in connection with the issuance of the Bonds, any compensation to be subsequently approved by this Governing Authority. The fee to be paid to the Municipal Advisor for services in conjunction with the issuance of the Bonds, together with reimbursement of out-of-pocket expenses incurred and advanced are contingent upon the issuance of the Bonds.

SECTION 4. Employment of Investment Bankers/Underwriters/Placement Agents. This Governing Authority finds and determines that a real necessity exists for the employment of investment bankers/underwriters/placement agents in connection with the sale of the Bonds with any compensation to be subsequently approved by this Governing Authority and to be paid from the proceeds of such Bonds and contingent upon the issuance of such Bonds. Accordingly, Crews & Associates, Inc., and Rice Financial Products Company, are appointed as the underwriters (together, the "Underwriters") in connection with the sale of the Bonds.

SECTION 5. Employment of Disclosure Counsel. This Governing Authority finds and determines that a real necessity exists for counsel to assist the Issuer with respect to continuing disclosure matters in connection with the issuance of the Bonds and accordingly, the Law Office of Lori C. Graham is hereby appointed and employed as disclosure counsel ("Disclosure Counsel") with respect to the issuance of the Bonds. The fee to be paid to Disclosure Counsel for such services shall be submitted to and approved by this Governing Authority and shall be contingent upon the issuance of the Bonds.

SECTION 6. Employment of Paying Agent /Trustee. This Governing Authority finds and determines that a real necessity exists for a paying agent/trustee with respect to the Bonds and accordingly, Regions Bank, Baton Rouge, Louisiana ("Regions"), is hereby appointed and employed to act as paying agent/trustee, in paying to the registered owners of the Bonds the principal, premium, if any, and interest on the Bonds and to act as registrar of the Bonds on the bond register, as well as holding any of the bond proceeds in trust as may be required by the bond documents, all in accordance with the terms of the Bonds. The fee to be paid to Regions for such services shall be submitted to and approved by the Governing Authority.

SECTION 7. Dissemination Agent. This Governing Authority finds and determines that a real necessity exists for the appointment of Digital Assurance Certification, LLC, as dissemination agent ("Dissemination Agent") in conjunction with issuance and post-issuance compliance matters associated with the Bonds. The Dissemination Agent is hereby appointed and is authorized to assist the finance team in conjunction with such matters. The fee to be paid to the Dissemination Agent for such services shall be submitted to and approved by this Governing Authority.

SECTION 8. Employment of Other Professionals. Should it be necessary to engage other professionals, the Authorized Officers (as defined below) shall be entitled to engage such professionals provided that any contracts employing such professionals shall be promptly submitted to this Governing Authority for formal approval thereof.

SECTION 9. Authorization of Officers. This Governing Authority hereby authorizes and directs its Mayor, Chief Administrative Officer, Director of Finance, Chairman, Vice-Chairman, Clerk and such other officials of the City individually and/or collectively (the "Authorized Officers") to do any and all things necessary and incidental to carry out the provisions of this resolution.

SECTION 10. Severability. If any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this

resolution which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this resolution are hereby declared to be severable.

SECTION 11. Bond Purchase Agreement. If deemed necessary upon advice of Bond Counsel, the Mayor, or any other Authorized Officer is hereby authorized and directed to enter into, execute and deliver a Bond Purchase Agreement, or such other equivalent document as may be necessary to contract the sale of the Bonds to the purchaser thereof (the "Bond Purchase Agreement"), with the Underwriters or purchaser of the Bonds in such form as the Authorized Officer deems appropriate upon advice of Bond Counsel provided however that no Bond Purchase Agreement shall be executed until Louisiana State Bond Commission approval is first obtained.

SECTION 12. Repealer. All resolutions in conflict herewith are hereby repealed.

WHEREAS, nuisances such as dust and noise pollution are causing health problems and loss of quality of life for these citizens; and

WHEREAS, some of the issues to be addressed in these public meetings and hearings are as follows:

- a. Meetings between citizens and drilling companies prior to the commencement of operations.
- b. Noise and dust mitigation efforts by drilling companies.
- c. Making oil and gas leases clearer.
- d. Drilling companies providing adequate contact information for citizens.
- e. Facilitating resolution of property damage issues between citizens and drilling companies without the need for legal action.
- f. Eliminating disparities in drilling companies' treatment of citizens.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport, in due, regular, and legal session convened, that the City Council does hereby urge and request the Louisiana Department of Natural Resources, Office of Conservation to hold public meetings and if necessary, public hearings, with citizens residing in the City of Shreveport, District A, Martin Luther King Community, regarding these nuisances as soon as possible.

Councilman Nickelson: Mr. Chairman, I'll just close my remarks on this legislation by saying that, you know, over the course of almost 18 years of practice I have represented oil and gas operators in lawsuits, and I've also represented landowners. In fact, I got a case set for trial just last week in Caddo District Court in which I represent landowners against an oil and gas operator in a dispute about usage of their land. So, I'm very sympathetic to the concerns that has

motivated Councilwoman Taylor to bring this legislation, she is an effective and passionate advocate for her district, and I appreciate that about her every time we sit down together. My concern about the legislation, again is that it has us requesting a blanket ban on drilling for six months from the Department of Natural Resources. I think it's very unlikely, exceedingly unlikely that DNR is going to impose such a ban, but our requesting it as the governing authority of this city, does send a message to oil and gas operators, oil, and gas lessees. Those who have said that oil and gas operators sometimes poor mouth and try to get everything they can to the detriment of landowners of course that has been true in some cases. That's happen in this community in recent years no doubt about that. But oil and gas operators in that industry, none the less, are just so critically important for our economy that I don't want us to adopt legislation that sends the wrong message that is not going to have the effect of imposing a moratorium because we, the city council don't have the legal authority to do that, we can only ask DNR and DNR, will in all probability decline that request. So, I respect the versions of options on this issue, I just wanted to make sure I stated mine for the record. Thank you.

Councilwoman Taylor: And as I appreciate that Councilman Nickelson and I do, let them make the decision to say no to that, if that's what they decide to do as it relates to that. Bu while we are here, so do our residences, they deserve a fair and equitable chance as well as the oil and gas industry. Because the oil and gas industry cannot do anything without their land. It's their land and they should be fair and sit down at the table and let's make sure that everybody is profitable at that particular point. So, if the Office of Conservation want to say no, then they will say no, but let's not, not provide them the opportunity show that we often have the support of our constituents here because we want them to be treated fairly.

Councilman Green: Mr. Chair, I would just like to say this for the record. I lived in Belcher growing up, my grandmother had a farm next to the Yam plantation, it's still there, but when I was growing up, I would ask my grandmother why we never had an oil well on our land. She said, well baby, we just don't have no oil. Well, the Yam plant plantation, they had wells less than fifty feet from my grandmother's land, they circled it. I didn't realize until I was grown that they were slant drilling. They would say to her when we would inquire about why nobody drilled on our land, they wouldn't give us no answer because they were slant drilling. If you go up there now, they probably got about thirty-five to fourty wells circling our land, but their land always had oil on it, and we had none and its less than twenty-five to fifty feet. And as I said oil and gas, they always poor mouthing and I am not talking about what I heard, I am talking about what I know. I am not going to put anybody on blast, but they are poormouthing, and I don't think that is right for them to do it to the Cooper Road or District A and to nobody else. I just think you ought to have a right to say no to your own land. In fact, I can't remember what president, but he put a, I don't want to misquote it, but he put somewhat of a band on oil and gas when he came in, so it's not like we're just sending a bad message, Washington D.C. has already set the standard. So, I don't have that information before me but that is already set and so, but I just wanted to throw that out (inaudible) as to how unfair they have been down through the years when it comes to majority of black neighborhoods, and I think it is very unfair. Thank you, Mr. Chair.

AN ORDINANCE TO AMEND THE OFFICIAL ZONING MAP OF THE CITY OF SHREVEPORT UNIFIED DEVELOPMENT CODE, BY REZONING PROPERTY LOCATED ON THE NORTH SIDE OF OVERTON BROOKS ROAD, APPROXIMATELY ONE THOUSAND SIX HUNDRED FEET WEST OF NORRIS FERRY ROAD, SHREVEPORT, CADDO PARISH, LA., FROM R-1-7, SINGLE FAMILY RESIDENTIAL DISTRICT TO R-E, RESIDENTIAL ESTATE DISTRICT, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

SECTION I: BE IT ORDAINED by the City Council of the City of Shreveport, Caddo Parish, LA, in due, legal and regular session convened, that the zoning classification of property located on the north side of Overton Brooks Road, approximately one thousand six hundred feet west of Norris Ferry Road, Shreveport, Caddo Parish, Louisiana, legally described below: be and the same is hereby changed from R-1-7, Single Family Residential District to R-E, Residential Estate District:

0.257 ACS. - M/L - THAT PART OF SW/4 OF NE/4 LYING W. OF K. C. S. R. R. R/W, SECTION 17, T16N, R13W, CADDO PARISH, LOUISIANA.

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications of this ordinance which can be given effect without the invalid provisions, items, or applications and to this end the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.
