AWARDS AND RECOGNITION OF DISTINGUISHED GUESTS, COMMUNICATIONS OF THE MAYOR RELATIVE TO CITY BUSINESS, AND REQUIRED REPORTS AWARDS AND RECOGNITION OF DISTINGUISHED GUESTS BY CITY COUNCIL MEMBERS, NOT TO EXCEED FIFTEEN MINUTES

Councilman Flurry: I welcome you and I would like to give everyone an update on my health. I continue to make progress and I just want to tell you that I feel all the prayers from the city, I feel them and I thank you from the bottom of my heart.

#### **Councilman Green made the following comments:**

- Asked CAO Whitehorn if Resolution No. 100 of 2020 pass, how much of a burden it would be on other city departments and the City of Shreveport at this point and time. CAO Whitehorn said they do not have all the details yet but it would only impact the Shreveport Police Department because it deals with vacant positions because that is the funding source. So, it would not affect any other department, but it would create problems within the police department on how they are able to respond to the calls for service. He did not have enough information to put out there regarding the pay raise because it has not been fully presented to the administration.
- Commended the Shreveport Police Department on how they handled an active shooter on Alton Street. Councilman Green said the officers were heroes and whatever training the department has started it is working.
- Asked the Chief to briefly explain the benefits of being a Shreveport Police officer.
- Asked Gary Norman to update the council on equipment needed in order for Public Works to maintain the upkeep of the city.

Councilman Nickelson: I, like everyone sitting around the horseshoe, is so thankful that Chairman Flurry can participate by video conference in this meeting. We've been praying for his good health and he seems to be on the mends. So, I am very appreciative of that, like all of us. I would life for the City Attorney briefly to explain why the Chairman is able to participate in this meeting because it's important for that to be on the record.

City Attorney Creal: I was presented with a case out of the Western District of Louisiana, it's a federal court case, where an injunction was granted against the City of Alexandria and that particular municipality was instructed to make the necessary provisions for a council member to participate electronically at city council meetings, both regular meetings and special meetings. I won't go into a detailed discussion about this particular case, but I did advise the Clerk of Council that the city would be reasonable by relying on this particular case, and that if his participation was challenged or if he himself challenged the city for not allowing him to participate, I would reasonable expect the court to rely on this ruling that they previously issued.

Councilman Nickelson: Thank you Mrs. Creal I thought that was important to have on the record because state law of course does generally require members to be present but we're glad Chairman Flurry can participate in the way that he is.

A RESOLUTION AUTHORIZING A REQUEST TO BE MADE TO THE LOUISIANA DEPARTMENT OF NATURAL RESOURCES, LOUISIANA STATE MINERAL AND ENERGY BOARD, TO SEEK PUBLIC BIDS FOR AN OIL, GAS AND MINERAL LEASE INVOLVING THE PROPERTY LOCATED IN DISTRICTS A, F AND G AND DESCRIBED HEREIN AND TO EXECUTE THE LEASE FOR CERTAIN MINERAL INTERESTS OWNED BY THE CITY OF SHREVEPORT; AND TO AUTHORIZE THE MAYOR TO EXECUTE ANY AND ALL DOCUMENTS RELATED TO THE INTENT OF THIS RESOLUTION; AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, the City of Shreveport ("City") may own certain mineral rights underlying the described property in Exhibit "A" ("the property"); and

WHEREAS, every agency [including every municipality] is authorized to lease its land for the development and production of minerals; and

WHEREAS, the City desires to lease its interest in the property for oil, gas and other minerals subject to conditions contained herein; and

WHEREAS, the Louisiana Department of Natural Resources, Louisiana State Mineral and Energy Board, is available upon the request of the City of Shreveport to seek public bids for an oil, gas and mineral lease and to execute the lease of the property described herein in Exhibit "A" for oil, gas and other minerals if requested to do so by the City of Shreveport; and

WHEREAS, this Resolution is authorized pursuant to Louisiana Revised Statutes, Title 30; Subtitle I; Chapter 2; Subpart B. Leases by State Agencies [and Municipalities] (La. R.S. 30:151 – 30:159); and WHEREAS, pursuant to La. R.S. 30:153(A), any agency [Municipality] may, by Resolution, direct the State Mineral and Energy Board to lease the City's interest in the property for such purposes; and WHEREAS, pursuant to La. R.S. 30:153(A), after the execution of the original lease, all rights and authority in connection therewith shall be vested in the agency [Municipality] to the same extent as if the agency [Municipality] had itself leased the land; and

WHEREAS, pursuant to La. R.S. 30:153(A) the bonus money, if any, received for the lease shall be transmitted by the State Mineral and Energy Board to the agency [Municipality];

WHEREAS, the City of Shreveport has received a written request from Joe K. McGinty, Jr., on behalf of McGinty-Durham, Inc., that the City seek public bids for an oil, gas and mineral lease covering said described property in Exhibit "A"; and

WHEREAS, the City of Shreveport does not, by way of the instant Resolution, guarantee Joe K. McGinty, Jr., on behalf of McGinty-Durham, Inc., or any other bidding entity, the award of successful bid on the described property in Exhibit "A" ("the property").

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport, Louisiana, in due, legal, and regular session convened, that:

- 1. The City of Shreveport declares it may own certain mineral rights underlying the following described property, to-wit: See Exhibit "A" Property Description
- 2. The Louisiana Department of Natural Resources, State Mineral and Energy Board, be and it is hereby requested and authorized to seek public bids for an oil, gas and mineral lease covering the property described herein above.
- 3. The Louisiana Department of Natural Resources, State Mineral and Energy Board, be and it is hereby requested and authorized to execute a lease covering the property described herein above. 4. The Mayor, Adrian Perkins, and/or his designee, is hereby authorized to execute, for and on behalf of the City of Shreveport, any and all documents related to the execution and intent of this Resolution.

5. Any such lease shall contain a NO SURFACE OPERATIONS provision to read the same or substantially the same as the following:

Lessee, its successors or assigns, may produce oil, gas and other minerals from the leased premises by drilling from a surface location on other lands, but notwithstanding any other provision of this lease, Lessee, its successors or assigns, shall not use the surface of the Lessor's property for drilling or any other operations without prior written permission of Lessor, which permission may be withheld at Lessor's discretion.

6. Any such lease shall contain a HORIZONTAL PUGH clause to read the same or substantially the same as the following:

Notwithstanding anything to the contrary herein contained, at the end of the primary term or any extension thereof by operations, if the Commission of Conservation of the State of Louisiana establishes a drilling unit which includes a part of the land herein leased, the production of oil, gas and other minerals from such unit shall maintain this lease in full force and effect only as to such portions of the leased land embraced in said pooled unit; and this lease shall expire as to that part of the land herein leased not included in such unit; and Lessee, its successors and assigns agrees to relinquish by formal instrument any portion of the leased land not included in a unit created by the Commission of Conservation while this lease is in effect.

7. Any such lease shall contain a VERTICAL PUGH clause to read the same or substantially the same as the following:

Upon the expiration of the primary term hereof or any extension thereof by operations, this lease shall automatically terminate and be of no further force or effect except as to all that part of the leased premises then included within the geographical boundaries of a producing unit duly established by governmental agency or authority having jurisdiction, from the surface of the earth to a depth of one hundred (100) feet below the deepest depth from which any well commenced during the primary term hereof on the leased premises or on lands pooled therewith is completed and from which there is production in paying quantities, such depth determination to be made on a unit-by-unit basis. In the absence of units so established, this lease shall terminate except as to forty (40) acres around each producing oil well and one hundred sixty (160) acres around each producing or shut-in gas well located on the leased premises, in as near the form of a square as is practicable, from the surface of the earth down to a depth of one hundred (100) feet below the deepest depth from which said well or wells are completed and from which there is production in paying quantities, such depth determination to be made on a well-bywell basis.

- 8. Any such lease shall contain a minimum CASH PAYMENT BONUS provision as follows: Cash Payment Bonus of not less than one thousand five hundred dollars (\$1500.00) per acre.
- 9. Any such lease shall contain a minimum ROYALTY provision as follows: Royalty of not less than twenty percent (20%).
- 10. Any such lease shall contain a maximum TERM provision as follows: Primary term of lease shall not exceed three (3) years.
- 11. Any such lease shall contain a provision expressly stating that any lease granted by the City of Shreveport and accepted by Lessee shall be WITHOUT WARRANTY OF TITLE and WITHOUT RECOURSE AGAINST THE CITY, whether expressed or implied, even for the return of any monies paid, and further, that City shall not be required to return any payments received or be otherwise responsible to Lessee therefore.
- 12. Any error in any legal description contained in this Resolution and/or in Exhibit "A" which may be discovered by the State Mineral and Energy Board, or its staff, during its review of the City's application, which are subsequently corrected by the City of Shreveport, provided such irregularities do not materially change the property being herein authorized for lease, shall not affect any authorization granted or conveyed herein and the State Mineral and Energy Board is hereby authorized to advertise and subsequently lease the said property as correctly described. 13. A certified copy of the executed

Lease Agreement authorized herein and all Exhibits attached thereto, or an extract thereof, shall be filed and recorded in the conveyance records of Caddo Parish, Louisiana.

WHEREAS, the City of Shreveport ("City" or "Landlord") is the owner of immovable property located at 1126 Texas Avenue, Shreveport, Louisiana, 71101, in Caddo Parish; and

WHEREAS, the City as "Landlord" desires to lease and rent to Man in Black, LLC. ("Tenant") a certain portion of land as described in the attached Lease Agreement for improvements to the subject property including creation of additional downtown public parking; and

WHEREAS, pursuant to Shreveport City Charter Section 2.03(a) the City may lease property; and WHEREAS, pursuant to La. R.S. 33:4712.2 the city of Shreveport may lease any property or portions thereof, including real property, owned by the city, which in the opinion of its governing authority is to be used for "purposes which benefit the public", in accordance with the procedures set forth in La. R.S. 33:4712; and

WHEREAS, pursuant to La. R.S. 33:4712.2(B), the term "purposes which benefit the public" shall mean operations of public or private enterprise which provide civic, recreational, educational, cultural, or social activities or opportunities to the public, which the city of Shreveport is otherwise authorized and empowered to provide through its own forces, but which in the opinion of its governing authority the city does not currently have the funds, expertise, or facilities to provide to the public directly; and WHEREAS, creation of an entrepreneurial space and additional public parking will be beneficial to the citizens of the City and will provide "opportunities" which serve a public purpose; and WHEREAS, Man in Black will use the lot for customer parking and any unused spaces may be used by the public. NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Shreveport, Louisiana, in due, regular and legal session convened, that:

- 1. As required by La. R.S. 33:4712(B), the location and description of the proposed lease area is described as: City-owned property located at 1126 Texas Avenue, Shreveport, Louisiana, 71101, in Caddo Parish, (hereafter referred to as the "Property").
- 2. As required by La. R.S. 33:4712(B), it is hereby stated that it has been determined by this City Council that it is in the best interest of the City to lease the Property.

- 3. In accordance with La. R.S. 33:4712.2, it is the opinion of the City Council of the City of Shreveport (Shreveport's governing authority) that the operations and use of the property will be used for "purposes which benefit the public".
- 4. Pursuant to La. R.S. 33:4712.2(A), any lease granted shall not exceed a term of twenty-five (25) years.
- 5. The Lease Agreement proposes an initial primary term of approximately twenty (20) years following the Commencement Date with the ability for renew terms for additional periods of one (1) year each.
- 6. The lease shall comply with all requirements set forth under federal, state and local laws and regulations.
- 7. Mayor Adrian Perkins of the City of Shreveport ("City") is hereby authorized to execute a lease, between the City of Shreveport ("Lessor") and Man in Black, LLC ("Lessee"), of the Property for improvements to the subject Property including creation of an entrepreneurial space and additional public parking, substantially in accordance with the draft of the Lease Agreement attached hereto.
- 8. The map of the area is attached hereto as Exhibit "A".
- 9. The City Council declares and confirms that the Lease Agreement is for a public purpose as defined in the Lease Agreement and constitutes a use of the property for public purposes and a cooperative endeavor between City and Man in Black, LLC as provided under Article VII § 14(C) of the Constitution of the State of Louisiana.
- 10. The Mayor of the City of Shreveport is hereby authorized to do any and all things and execute any and all documents necessary to carry out the lease of the Property or take any action in furtherance or necessary to complete the terms and intent of this Ordinance.
- 11. A certified copy of the executed Lease Agreement authorized herein and all Exhibits attached thereto, or an extract thereof, shall be filed and recorded in the conveyance records of Caddo Parish, Louisiana.
- 12. The City Council declares and confirms, in accordance with La. R.S. 33:4712, that notice of this ordinance was published at least three (3) times within fifteen (15) days, one week apart prior to adoption of said ordinance and all other procedural requirements have been met.

- 14. Subject to the conditions expressed in the above paragraph and in accordance with the requirements of La. R.S. 33:4712(C), if no order restraining the disposition of the property has been issued by the District Court, the effective date of this Ordinance shall be ten (10) days after its adoption/passage and cannot be contested for any reason thereafter.
