**RESOLUTION NO. 119 OF 2021**

**A RESOLUTION ENCOURAGING THE METROPOLITAN PLANNING COMMISSION (MPC) TO PLACE A MORATORIUM ON THE ISSUANCE OF ANY OCCUPATIONAL LICENSES AND CERTIFICATES OF OCCUPANCY FOR LIQUOR STORES/RETAIL SALES OF ALCOHOL – LIQUOR, OTHER THAN RENEWALS, FOR A PERIOD OF SIX (6) MONTHS, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO**

**BY COUNCILMEMBERS: TABATHA TAYLOR AND JOHN NICKELSON**

WHEREAS, the City of Shreveport is committed to undertaking a comprehensive review of its zoning and land use classifications and regulations in regard to liquor stores/retail sales of alcohol – liquor to better serve, protect, and promote the health and welfare of its citizens; and WHEREAS, the City Council believes that it is in the best interest of the City of Shreveport for the Metropolitan Planning Commission (MPC) to establish a moratorium on the issuance of new occupational licenses and certificates of occupancy to any liquor store/retail sales of alcohol – liquor pending further study and revision of its land use policies and regulations; and WHEREAS, a six (6) month moratorium on the issuance of new occupational licenses and certificates of occupancy to any liquor store/retail sales of alcohol – liquor will allow the City time to develop a plan and guidelines for liquor stores moving forward.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport, in due, legal and regular session convened, that the Metropolitan Planning Commission (MPC) is hereby encouraged to place a moratorium on the issuance of any occupational licenses and certificates of occupancy for liquor stores/retail sales of alcohol – liquor, other than renewals and approvals for retail sales of alcohol – liquor previously granted that have yet to be issued an occupational license or certificate of occupancy, for a period of six (6) months.

BE IT FURTHER RESOLVED that if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items, or application of this resolution which can be given effect without the invalid provisions, items, or application and, to this end, the provisions of this resolution are hereby declared servable; and

BE IT FURTHER RESOLVED that all ordinances or resolutions or parts thereof in conflict herewith are hereby repealed.

**A RESOLUTION RECOGNIZING PROJECT CELEBRATION FOR ITS WORK TO PREVENT AND TO ASSIST THE VICTIMS OF DOMESTIC VIOLENCE; TO SUPPORT DOMESTIC VIOLENCE AWARENESS MONTH, AND OTHERWISE PROVIDING WITH RESPECT THERETO**

WHEREAS, Project Celebration, Inc. is an organization committed to helping individuals and families enhance their ability to live successfully in the community. One program offered by Project Celebration is the Domestic Violence Program with shelters; and

WHEREAS, domestic violence is a serious crime that affects people of all races, ages, gender and income levels; and

WHEREAS, in accordance with Shreveport City Charter Section 4.13 the Shreveport City Council shall adopt rules defining the duties of the chairman, vice chairman and the clerk of council, and governing its employees, organization of any of its committees, the time, place and procedure of its meetings, including the procedure provided for in Section 4.30, and the transaction of its business; and

WHEREAS, said rules of procedure have been adopted and are codified in the City's online publications as Appendix "A" - City Council Rules of Procedure (to the Code of Ordinances, City of Shreveport, Louisiana); and

WHEREAS, in accordance with Shreveport City Charter Section 11, sub-section 11.1. the City Council Rules of Procedure may be amended, altered, supplemented, or repealed in whole or in part only by two-thirds (2/3) vote of the council taken at a regular meeting or at a special meeting called pursuant to legal notice; and

WHEREAS, pursuant to Shreveport City Charter Section 4.13 such City Council Rules of Procedure shall not become effective until entered into the book of rules (a public record) to be kept and indexed by the clerk of council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Shreveport, Louisiana, in due, regular and legal session convened that Section 1 of the City Council Rules of Procedure be hereby amended to now read as follows:

Public comments may be made during this public comment period on any matter of public concern regardless of whether the item is on the agenda during the administrative conference and only matters which are on the agenda during the regular meeting.

**A RESOLUTION HONORING DR. ANDIA AUGUSTIN-BILLY AS THE FIRST AFRICAN AMERICAN FACULTY MEMBER TO TENURE AT CENTENARY COLLEGE OF LOUISIANA IN THEIR 196-YEAR HISTORY AND OTHERWISE PROVIDING WITH RESPECT THERETO.**

WHEREAS, Dr. Augustin-Billy received her Ph.D. in French Language and Literature, her M.A. in French Language and Literature, and a Certificate in Women, Gender and Sexuality Studies from Washington University in St. Louis, MO. She received her B.A. in French Language and Literature from Lee University in Cleveland, TN; and

WHEREAS, Dr. Augustin-Billy served as an Assistant Professor from July 2015 until she became an Associate Professor of French and Francophone Studies in July 2021 at Centenary College of Louisiana; and

WHEREAS, Dr. Augustin-Billy's teaching and research fields include French literature, francophone literature, French language, literary theory, feminist theory, performance studies,

cultural studies, Haitian studies, women, gender, and sexuality studies, and African diasporic studies, postcolonial; and

WHEREAS, Dr. Augustin-Billy's publications include: "Tu es ridicule!": When Black Women Speak Up and Speak Out in Ferdinand Oyono's Novels." MIFLC Review 19, (2020): 57-70; "A Conversation with Lavar Munroe." In Devil in a White City: A Painting Series by Lavar Munroe. Shreveport: Publications of The Meadows Museum of Art, 2018. 38-41, "Ayiti pa lakay ankò: Assotto Saint's Search for Home." Journal of Haitian Studies, 22.1 (2016): 82-105, and "The Disabled Body in the Fabliaux." Postmedieval: A Journal of Medieval Cultural Studies 3.2 (2012): 158-167; and

WHEREAS, Dr. Augustin-Billy is a member of the Academic Policy Council and is currently serving as the Faculty advisor for La Légion d'honneur louisianaise, the faculty advisor and organizer for La Table française, the faculty advisor for Le Quartier français, LLC and editor of Le Tintamarre French Language Newspaper in the Department of Foreign Languages at Centenary College, and has chaired and served on numerous other committees at Centenary College; and

WHEREAS, Dr. Augustin-Billy is a member of the American Association of University Professors, African Studies Association, Caribbean Studies Association, Haitian Studies Association, and Modern Language Association; and

WHEREAS, Dr. Augustin-Billy is the recipient of numerous awards, grants, and fellowships, including the Mellon Emerging Faculty Leaders Award in 2019, the Harry Blake Education Award in 2018, and William C. Arceneaux Chair in French Studies since 2015; and

WHEREAS, Dr. Augustin-Billy speaks four languages fluently; English, French, Haitian Creole, and Spanish; and

WHEREAS, Dr. Augustin-Billy spends the summers travelling with Centenary students to Haiti teaching Haitian culture and traditions and travels with the incoming freshman class to Paris, France teaching the Paris Noir course which explores the life and history of African Americans in France; and

WHEREAS, Dr. Augustin-Billy is married to a local attorney Emmanuel Billy and is the mother of a daughter and two sons.

#### **AN ORDINANCE AUTHORIZING AN ENCROACHMENT INTO THE CITY'S PUBLIC RIGHT-OF-WAY LOCATED AT 629 SPRING STREET, AS MORE FULLY DESCRIBED HEREIN, AND TO AUTHORIZE THE MAYOR, OR HIS DESIGNEE, TO EXECUTE AN ENCROACHMENT PERMIT WITH SHREVEPORT-BOSSIER CONVENTION & TOURIST BUREAU AND TO OTHERWISE PROVIDE WITH RESPECT THERETO**

WHEREAS, pursuant to Shreveport City Charter Section 4.17, every ordinance or resolution granting, amending or extending any right to occupy or use public places in the City for any purpose, shall be complete in the form in which it is finally passed, shall remain on file with the clerk of council for public inspection for at least one (1) week before the final passage or

adoption thereof, and shall be published once, together with a notice of the time at which the City Council proposes to take final action thereon, in the official journal at least one (1) week before the final passage or adoption thereof; and

WHEREAS, pursuant to Shreveport City Charter Section 2.03 (e), the City shall have the power to permit encroachment over, under or in any street, alley, sidewalk or other public place, where such encroachment does not adversely affect the public interest, upon such conditions, including regulation of the construction, suspension, and, if necessary, the removal of awnings, signs, lights, marquees, balconies or other structures projecting from buildings, as may be established by ordinance, and to provide for charges to be paid for such privilege; and

WHEREAS, pursuant to Shreveport City Charter Section 2.03 (g), the City shall have the power to make regulations for the prevention of injury to any street, alley, sidewalk or public place, and the pavement, curb, gutter, trees, plants, shrubs, ornamental lighting fixtures, traffic signs and signals and other property of the City therein; and

WHEREAS, Shreveport City Code Sec. 78-122 authorizes the City to permit the encroachment over, under, or in any street, alley, sidewalk or other public place, where such encroachment is not a facility, defined by Sec. 78-120, and does not adversely affect the public interest; and

WHEREAS, an applicant for an encroachment permit shall make application to the City Department of Engineering and Environmental Services and pay the applicable application processing fees; and

WHEREAS, the City's Engineering and Environmental Services Department has received an application, for an encroachment permit in accordance with Shreveport City Code Sec. 78-122, attached as EXHIBIT "A"; and

WHEREAS, the City Engineer is authorized to establish a policy and regulations for the issuance of such encroachment permits;

WHEREAS, Shreveport-Bossier Convention & Tourist Bureau is the owner of record of Lot 1, Tourist Bureau Subdivision Unit 1, City of Shreveport, Caddo Parish, Louisiana and identified by Caddo Parish Tax Assessor's Geographic Number 181437-194-0001-00 and located at 629 Spring Street; and

WHEREAS, City Departments and utility companies which could be affected by this encroachment have been contacted and do not object to this proposed encroachment; and

WHEREAS, this encroachment upon and use of a portion of this public right-of-way is not adverse to the public interest of the citizens of the City of Shreveport; and

WHEREAS, the City Engineer, or his designee, has reviewed the submitted application and other supporting documents and does hereby recommend the City Council approve the proposed encroachment as it appears to comply with the Shreveport City Code and City departmental policies and regulations; and

WHEREAS, pursuant to Shreveport City Code Sec. 78-122 an encroachment permit shall be authorized by ordinance of the City Council and executed by the Mayor, or his designee.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Shreveport, Louisiana, in due, legal, and regular session convened, that:

SECTION 1. All the above "Whereas" clauses are adopted herein as part of this Ordinance.

SECTION 2. The encroachment permit application (Exhibit "A") is hereby approved for SHREVEPORT-BOSSIER CONVENTION & TOURIST BUREAU, more fully described in EXHIBIT "B" Encroachment Permit, and the Mayor, or his designee, is hereby authorized to execute the Encroachment Permit, substantially in accordance with the draft of the Encroachment Permit attached hereto as EXHIBIT "B", to include any other related and

accompanying documents to carry out the intent of this Ordinance, between the CITY OF SHREVEPORT, LOUISIANA (“CITY”) and SHREVEPORT BOSSIER CONVENTION & TOURIST BUREAU, for the purpose of allowing an encroachment over, under, or in any street, alley, sidewalk or other public place.

SECTION 3. SHREVEPORT-BOSSIER CONVENTION & TOURIST BUREAU agrees it will hold the CITY harmless for any damages that may result to the sign, water service appurtenances, parking lot paving, electrical cabinet, security fencing, gates, or other improvements because of its location upon the Crockett Street public right-of-way.

SHREVEPORT-BOSSIER CONVENTION & TOURIST BUREAU also agrees to inform any buyers of said property in writing of this agreement with the CITY

SECTION 4. SHREVEPORT-BOSSIER CONVENTION & TOURIST BUREAU further promises it will terminate the encroachment within Crockett Street public right-of-way upon request of CITY, if and when CITY shall determine that a need exists for the public use of the encroachment or a portion thereof. The removal shall be at SHREVEPORT-BOSSIER CONVENTION & TOURIST BUREAU (or the successor owner's) expense and shall be made in an expeditious manner.

SECTION 5. The Mayor of the City of Shreveport, or his designee, shall be and is hereby authorized to do any and all things and to sign any and all documents in a form acceptable to the City Attorney, or his/her designee, necessary to effectuate the purposes set forth herein.

SECTION 6. The original Encroachment Permit and a certified copy of this ordinance shall be filed and recorded in the Conveyance Records of Caddo Parish, Louisiana.

BE IT FURTHER ORDAINED that if any provision or item of this Ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this Ordinance which can be given affect without the invalid provisions, items or applications and to this end the provisions of this Ordinance are hereby declared severable.
